COMMONLY KNOWN AS CBI SCHEMES

Citizenship by Investment (CBI) schemes are paid citizenship schemes that offer instant passport within 3 months by purchasing real estate or one time donation to the state. Prices start from \$100,000 onwards. There are currently more than 10 active CBI schemes run by Governments in the Pacific, Caribbean and Europe. These schemes have become only popular after 2010.

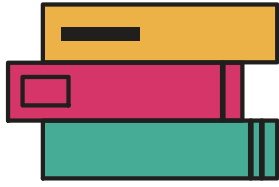

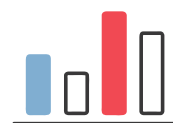
