Golden Visas ("GV") are residence by investment schemes that offer instant permanent residency in exchange for investments. The investments could be active or passive in real estate, business capital, job creation and purchase of interest free government debts (bonds, stocks, securities).

Portugal first invented the name "Golden Visa" in 2012, when ARI scheme launched for investment activity.

Golden visas also known otherwise as as "Immigrant investor programs"

As of 2020, there are more than 20 countries that have official golden visa schemes, these are listed below.
Unofficially there are over 100 countries that offer visas for investment.

Officially there are more than 20 countries that operate golden visa schemes. Unofficially more than 100 countries in the world offer visas for investments

Golden visa industry is adding on an average \$12 billion every year according to our calculations in 2020

UNITED STATES

EB-5 IMMIGRANT INVESTOR

The EB-5 (Employment-based fifth preference) immigrant investor program dubbed as 'American golden visa scheme' is the world's most popular scheme to immigrate to the United States for wealthy foreigners.

Congress created the EB-5 Program in 1990 to stimulate the U.S. economy through job creation and capital investment by foreign investors. Regional Center Program was introduced in 1992.

The EB-5 program was reformed in Nov 2019 increasing the minimum to \$900,000 (from \$500,000)

High Employment Area: (HEA): USD 1.8 million

Job Creation: Atleast 10 jobs

Waiting Time: 2 years - 5 years

US Citizenship time: 5 years

MALTA

MALTA RESIDENCE VISA (MRV)

Malta has the cheapest golden visa program in Europe. This passive scheme offers instant permanent residence status to third country nationals investing in Malta.

The MRV scheme was launched under Malta Residence and Visa Programme Regulations, 2015

Malta remains one of the best countries in the world to live, work, study and retire.

English is the official language and has world class healthcare and education system in the world.

The Maltese passport is one of the powerful EU passport in the world

GREECE

GOLDEN VISA

Greece is the most popular golden visa program in Europe.

The real estate market prices still recovering and affordable compared to other member states in the European Union. Airbnb, Tourism and Golden visa program drive the property prices in Greece.

Greece offers attractive tax regime such as VAT exemption, low property registration costs for foreign property investors makes investing in Greece more interesting.

Greece has free schooling, excellent healthcare system and the Greek passport remains powerful EU passport in the world Investment: EUR 250,000 in Real

ARI / GOLDEN VISA

Portugal is the 3rd safest country in the world with high standards of european living.

Portugal launched golden visa scheme in 2012, since then it has become the biggest and most popular program, a major driving force of the property market in Portugal.

Wealthy Chinese, Brazilians and South Africans are the biggest investors in Portuguese Golden Visa (PGV) scheme snapping up luxury properties averaging 550,000€ in Lisbon and coastal areas

Portugal offers tax exemption for cryptocurrency investors makes the country attractive for startups and fintech companies. The Citizenship time also reduced from 6 years to just 5 years.

IMMIGRANT INVESTOR PROGRAM

Ireland emerged the most popular investment migration destinations for HNWI since Brexit vote.

Ireland is the business friendly country attracts major investments due to low corporate taxes also attract several tech companies to Ireland.

Ireland offers investment based residency to HNWIs and UHNWIs through the Irish immigrant investor programme at half the price of UK tierl investor scheme.

Ireland is a EU member state but has opted out of the schengen area. The demand for irish passports sky rocketed since Brexit Investment: EUR 500,000 (donation) or EUR 1m investment funds

What is a Golden visa?

Golden visas are residence by investment schemes with an optional path to naturalize for citizenship in the future.

What is the difference between visa and residence permit?

Visas are short term validity (less than 90 days). Residence permits are issued for long term (more than 3 months). Another difference is visas can only be extended through the embassy in your home country, whereas residence permits can be extended at immigration offices.

What are the benefits of permanent residency?

New life, new country, children can study in the best universities, high quality living, free movement, opportunity to invest in real estate.

What is the validity of permanent residence cards?

5-10 years

Are there any language tests for citizenship?

Yes, most countries will require you to be fluent in their language, pass language and citizenship tests.
