## MONTENEGRO IS PROJECTED TO JOIN EUROPEAN UNION BY 2025

Montenegro is a brand new and super exciting citizenship program in Europe.

### What makes it special?

It is called a 'special' citizenship program because this limited program will only run until 2022 and capped to only 2000 foreign investors will receive this citizenship benefit for investments.

### Investment destination

Montenegro has become one of the most prestigious investment destinations in Europe. In 2018, Montenegro opened special citizenship for investments for about 2000 investors. From this scheme Montenegro likely to receive close to €1 billion investments mostly injected into tourism and real estate, agriculture and other sectors. Should Montenegro join EU anytime in the future, all Montenegro citizens will be granted full EU citizen status and rights.

### How much it costs?

You have to invest 250,000 EUR in real estate plus there is 100,000 EUR Govt per application fee. There are additional costs, but you should expect close to 400,000 EUR as total costs if you want a Montenegro passport.

Montenegro has opened 31 out of 33 chapter negotiations are going on with European Commission.

### NATO membership

On 3 June 2017, Montenegro joined NATO and became the Alliance's 29th member, a development that represents a major step forward on the country's pro-Western course. Montenegro's position as a fully-fledged member of NATO, has made safe and secure destination, significantly improved its business environment and opportunities in Montenegro, contributed to its overall not only social but also economic affirmation and created new opportunities for development. The inflow of foreign direct investment from NATO member states has reached over 60%.

# DO YOU KNOW?

## MONTENEGRO

Montenegro was mentioned as Montenegro in 1397, as Monte Nigro in 1443 and as Crna Gora in 1435 and 1458, but there are much older papers of Latin sources where Montenegro is mentioned as Monte nigro.

The first mention of Montenegro (as Monte nigro) dates to 9 November 1053 in a papal epistle.

The native name Crna Gora, also meaning "black mountain," came to denote the majority of contemporary Montenegro in the 15th century

The Black mountain derives from the appearance of Mount Lovćen when covered in dense evergreen forests

# MONTENEGRO EU RELATIONS

## WHAT IS HAPPENING WITH NEGOTIATION CHAPTERS?

### Negotiation chapters

At present, it has opened 31 of a total of 35 negotiation chapters, and has provisionally closed three chapters.

Chapters 23 and 24 will be in the spotlight the most. These chapters are related to the judiciary, freedom of expression, fundamental rights, and justice, freedom, and security, are the cornerstone of the rule of law and a precondition for a country's democratic and also economic development. On 30-06-2020 Negotiations were opened on Chapter 8: Competition policy.

Montenegro still needs to lot of work to do on its legal and judicial system, environment, fight against corruption, money laundering, women's rights, organized crime, freedom of expression before becoming a full EU member state. Montenegro is also assessed as being moderately prepared in developing a functioning market economy, irregular migration and democracy in line with the EU standards. On 15 October 2007,

Montenegro signed the Stabilisation and Association Agreement (SAA) in Luxembourg, thus establishing a legal foundation for relations with the EU.

### EU membership

Montenegro applied for EU membership in December 2008, and its Stabilisation and Association Agreement, the legal foundation for relations with the EU, entered in force in 2010. EU Membership is a strong incentive for further political and economic development of Montenegro, which bring many extended benefits to Montenegrin citizens. The Government has made projections that within the next five years Montenegro will be internally ready to join the EU.

### Visa liberalisation

On 1 January 2008, the visa facilitation and readmission agreements between Montenegro and the EU entered into force. Montenegro was added to the list of visa exempt nationals on 19 December 2009, allowing their citizens to enter the Schengen Area. The Visa liberalisation process does not include travels to Ireland or the United Kingdom as these countries operate their own respective visa regimes outside of the Schengen Agreement.

### Euro

Montenegro has no currency of its own, unilaterally adopted the euro in 2002 as its de facto domestic currency (not a legal tender).

### SCHENGEN AMBITIONS

In 2019, Montenegro announced intention in joining schengen area after EU accession with harmonisation of national legislation and standards with the Schengen acquis,

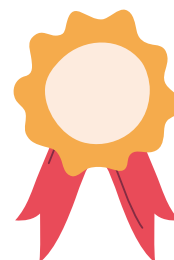

Vanuatu citizenship program remains the most popular passport scheme in 2020. The popularity soared in 2020 due to speed of processing, simple documentation process and visa free benefits of the passport for the right price. Real estate investments do not qualify for citizenship. At present only DSP/VCP donation options are available.

As of Q2 2020, Vanuatu has raised over 7.2 billion vatu and issued over 5000 passports to investors and their families.

Vanuatu is the only official citizenship by investment program in the pacific, offering commonwealth passport with tax free benefits. There is no personal visit required and oaths accepted online.

Economic citizens do not have right to vote, hold public office or enter politics.

The biggest difference between the Caribbean and the Vanuatu DSP/VCP schemes is the contribution fees. Unlike other Caribbean programs, Vanuatu citizenship program has Lawyer/Agent fees already included in the contribution.

Located geographically at at one of the riskiest locations for natural disasters, Vanuatu has been battling disaster after disaster and revenues from citizenship for sale program has been providing much needed lifeline against such potential risks.

# **BUNGEE JUMPING**

## **INVENTED IN VANUATU**

Bungee jumping was first invented here in Vanuatu. When the yam crop emerges in early April on Vanuatu's Pentecost Island, the locals begin to build high wooden towers (around 20 to 30 meters). Once completed, and until about the end of May, village men and boys dive from these rickety structures with vines attached to their ankles.

Vanuatu is widely recognised as one of the premier vacation destinations for scuba divers wishing to explore coral reefs of the South Pacific region.

What makes Portugal so attractive?

IN THE SPOTLIGHT

First of all you should know, Portugal Government offers 20% discount from 350K euro (reduced to 280K euro) if you make property investment in rural or low density areas.

Many foreigners do not know this, as most agents and real estate developers only promote 350K euro properties. Portugal is a very good and equally competitive golden visa program in Europe.

Portugal is the only golden visa program in the world where it is possible to acquire EU citizenship after 5 years. There are no strict living or residence requirements for Portuguese citizenship.

All other golden visa programs require you to physically live for more than 5 years to become EU citizens. This makes Portugal a very interesting Golden visa program if you are pursuing EU citizenship on the long run.

New born children can become Portuguese citizens after one year if parents (alien) legally in Portugal with residence permits.

You must make 280K euro real estate investment in Portugal to receive long term residency through golden visa residency. You must visit Portugal 2 weeks every year to keep your residence alive.

# DOMINICA CITIZENSHIP Q&A

BY BEST CITIZENSHIPS

## **Where can i get application forms?**

All application forms for the Citizenship by Investment Programme can only be obtained through an Authorised Agent.

## **How much is Dominica passport?**

Prices start from \$109,950 plus lawyer fee for single applicant under donation. Additional costs apply for family members. Real estate minimum is \$200,000

## **How to apply for Dominica citizenship?**

As an applicant for citizenship, you must be at least 18 years of age, of good character, without a criminal record, and able and willing to make the required contribution. You must engage an Authorised Agent or lawyer (we can help) who will assist you in preparing the required forms and supporting documents. There are also limitations if you are a citizen of Iran, North Korea, Sudan, and Syria.





### **Are there any taxes in Dominica?**

Taxes are not based on citizenship. There are no wealth, gift, inheritance, foreign income, or capital gains tax in Dominica. As a citizen, you would be liable to pay personal tax if you resided in Dominica.

### **How to take Oaths?**

Each applicant is required to sign an Oath of Allegiance to the Commonwealth of Dominica upon receiving citizenship. The Oath must be signed before a Notary Public, Justice of the Peace, or Commissioner of Oaths.

### **How to renew expired Dominican passport?**

You can renew your passport at the Passport and Immigration Department in Dominica or through any Dominican Consulate, and may simply give your primary residence as your address.

### **What are the processing times?**

Please allow 90 days from submission of the application to an approval in principle, applicants.

### **What is the validity of Dominican passport?**

Dominican passports are generally valid for up to 10 years. Passports for children under 16 years old are issued for 5 years.

### **Can i add family members for passports?**

Dominica is a complete family oriented program. You can add siblings, biological children. You can also add your spouse, parents and new born children post citizenship of main applicant.

### **Can i invest in real estate?**

Yes you can invest \$200K in shares or freehold titles. You must maintain the investment for 3 years before selling the property.

### **How many countries i can travel visa free using Dominican passport?**

Dominica citizens had visa-free or visa on arrival access to 140 countries. These countries include UK, Ireland, Schengen area, Russia, Brazil, Israel etc.

### **How do i start the application process?**

You can start the application process by paying 50% of lawyer fee and Govt due diligence fee. Wait for letter of approval issued by government until 90 days. Once the approval is issued close the remaining investment for your passport to be issue. If you are refused you dont need to make the investment.

### **Are there any discounts available?**

Dominica CIU has slashed govt prices for families upto four by USD 15,000.

# POST CITIZENSHIP ADDITIONS

Dominica's 2020 Regulations have expanded the ways in which an economic citizen can make a post-citizenship addition for his or her family members. This includes additions of new born children and newly married spouses.

# HOW TO GET E-2 VISA?

How to gain backdoor access to E-2 investor visas to immigrate to United States, through a cheapest and faster way?

The United States offers two types of visa for investment. EB-5 known as 'Golden visa' and E-2 the 'Investor visa'. E-2 visas provide the cheapest and fastest route to immigrate to United States.

## IMPORTANT DIFFERENCES

Here are the important differences you should know.:

EB-5 is a direct green card program costing \$900K whilst E-2 is a non-immigrant visa issued for period of 2 years for a business investment starting with \$100,000. E-2 visas have the fastest approval times (3 weeks) while the wait for EB-5 can take 2 to 10 years depending on the country.

Only few nationalities eligible for apply for E-2 visas. For example nationals of China, India, Russia cannot apply unless there is a E-2 treaty with US.

This is where CBI programs comes to play, offering an indirect access to E-2 visa opportunity. You become a citizen of second country through citizenship by investment (eg. Grenada is the cheapest), then apply for E-2 visa at any nearest US consulate where you live.

Please note only CBI programs running in Turkey, Grenada, Montenegro and Bulgaria offers access to E-2 visa opportunity. All other CIPs do not provide this exclusive visa benefit.



If you want a Citizenship by investment (CBI) passport, plus E-2 visa to United States, in general you should be able to invest atleast US\$ 250,000 in the package. Families can be included.

The cheapest path we recommend is through Grenada. The more the investment for example \$250,000, the better the chances of E-2 approval.

- Grenada - \$150,000 (passport donation)
- E-2 Visa - \$100,000 (investment)
- Total: \$250,000

These countries for example **do not** have E-2 treaty with United States, as a result nationals of these big economic countries do not have an opportunity to apply for E-2 visas directly. They must use citizenship by investment to become eligible for E-2 visas

- India
- Brazil
- Vietnam
- Brazil
- Russia
- Indonesia
- Nigeria
- South Africa
- Lebanon

Careful tax planning is required before the E-2 visa applicant moves to the United States. The US taxes its residents and citizen based on worldwide income.

It makes everything easier if you hire a US lawyer who specializes in Grenada and Citizenship by Investment. Here is the process

- Become a Citizen in any of the above 4 CBI countries
- Hire a US lawyer for E-2 paperwork (we can help)
- Apply for E-2 visa at US embassy in your country where you live (no need to travel abroad).

CBI programs Dominica, St Lucia, St Kitts and Antigua DO NOT provide E-2 visa opportunity for investor citizens.

Each US visa program has distinct advantages and requires careful planning. Please plan accordingly. In short, The E-2 investor visa is the easiest route to open a business in the United States with a minimal investment.

# NOW ADD SIBLINGS FOR ST KITTS

Previously it was not possible to add brothers and sisters (siblings) of main applicant for SKN citizenship by investment.

St Kitts and Nevis Government on Nov 6, has announced easing of restrictions to add siblings (brothers and sisters) of main applicant for the citizenship by investment program. These amendments were published in Citizenship by Investment (Amendment) Regulations SRO No 42 of 2020.

## CONDITIONS

Main applicants, can now add siblings to CBI application by meeting three conditions

1. Less than 30 years old.
2. Must have Unmarried and no children
3. Financially independent

## COSTS

The additional costs to add sibling of main applicant are as follows

SGF donation: US\$ 20,000 per sibling  
Real Estate: US\$ 40,000 per sibling

## COVID

Due effects of Covid, St Kitts CIU also offers a limited time covid discount of \$45,000 for family of four applying under the SGF donation option.



# ST KITTS & NEVIS

## DO YOU KNOW?

St Kitts and Nevis is the 8th smallest country in the World with a small population of just 55,000.

St Kitts and Nevis is the only federation in the Caribbean.

It is also the first islands in the Caribbean to be colonized by Europeans. Saint Kitts was home to the first British and French colonies in the Caribbean, and thus has also been titled "The Mother Colony of the West Indies".

Saint Kitts was named Liamuiga, which roughly translates as 'fertile land', by the Kalinago, who originally inhabited the island. This name is preserved via St. Kitts's tallest peak, Mount Liamuiga.

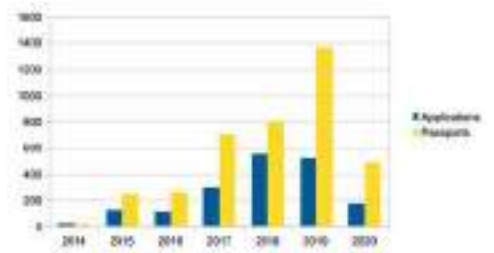

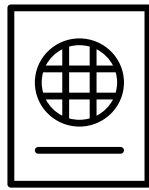
