Our Ranking Methodology

PBS SCORING MODEL

We are publishing our study on citizenship by investment programs for a second year in a row.

Our PBS (points based scoring) model, which we designed last year, is one of a kind in the industry, ranks Best CBI program taking into account 37 important factors looking by clients before deciding on their favorite investment citizenship program.

We have considered these 37 important factors into our PBS scoring model. Each ranking factor is assigned 10 points making it a total of 370 points.

CBI Programs that require personal visit or trips have fallen in rankings this year as Covid has made it impossible to travel for investors..

RESULTS



Our findings on the rankings for Best Citizenship by Investment Programs. Our PBS model scored after evaluating 37 important metrics. Note that Cyprus and Moldova remain suspended removed from rankings

COMMONLY KNOWN AS CBI SCHEMES

Citizenship by Investment (CBI) schemes are paid citizenship schemes that offer instant passport within 3 months by purchasing real estate or one time donation to the state. Prices start from \$100,000 onwards. There are currently more than 10 active CBI schemes run by Governments in the Pacific, Caribbean and Europe. These schemes have become extremely popular after 2010. In just 10 years the CBI has become a billion dollar industry attracting investors from all over the world.

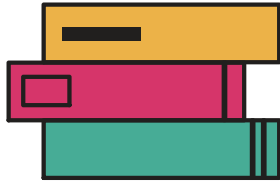

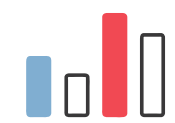
