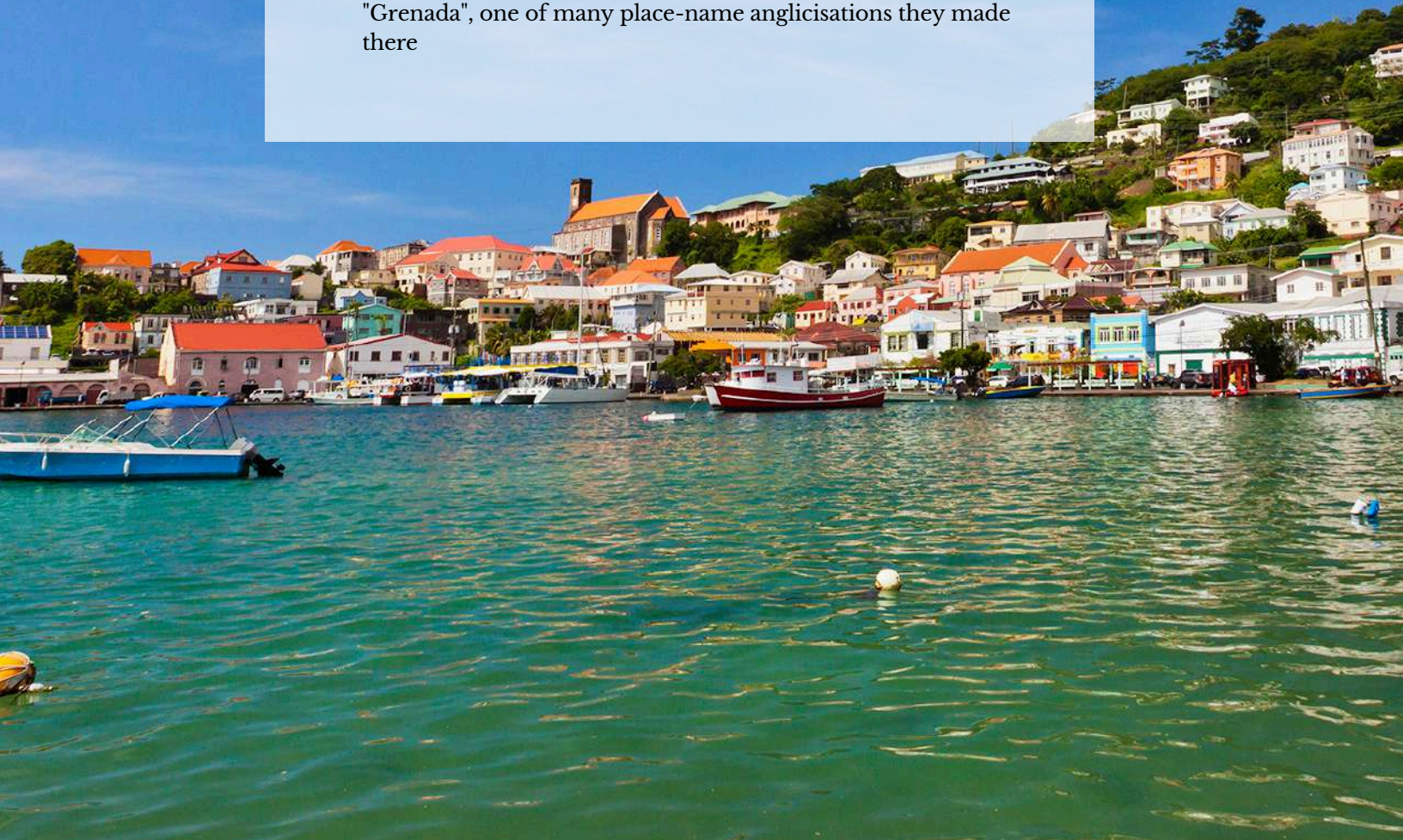
ORIGINS OF 'GRENADA'

The Origins of the name 'Grenada' may likely come from Spanish sailors who named after the island for the Andalusian city of Granada.

On his third voyage to the region in 1498, Christopher Columbus sighted Grenada and named it "La Concepción" in honour of the Virgin Mary.

The French maintained the name ("La Grenade" in French) after settlement and colonisation in 1649.

On 10 February 1763, the island of La Grenade was ceded to the British under the Treaty of Paris. The British renamed it "Grenada", one of many place-name anglicisations they made there

Grenada Citizenship by Investment Unit (IMA) through [Circular No. 2 of 2024](#) has announced new prices for CBI programme in accordance with the [Memorandum of Agreement \(MoA\)](#) among the Member States of the Organisation of Eastern Caribbean States offering Citizenship by Investment Programmes (CBIPs), a new pricing structure for the Investment Migration Agency Grenada (IMA) will be implemented effective July 1, 2024.

Under the new framework, the minimum investment requirement for the Grenada Citizenship by Investment Programme will become US\$235,000.00. The threshold was increased from current old prices \$150,000 (NTF donation) and \$200,000 (real estate).

The [Grenada Citizenship by Investment \(Amendment\) Regulations, 2024](#) outlines the revised pricing structure for NTF donation and Real Estate investments:

National Transformation Fund (NTF)

- Single Applicant or a family of up to 4 - US\$235,000
- Additional dependents - US\$25,000/\$50,000
- Sibling - US\$75,000

Approved Project Investment (Real Estate)

- Single Applicant or a family of up to 4 - US\$270,000
- Government Contribution - US\$50,000
- Additional dependents - US\$25,000/\$50,000
- Sibling - US\$75,000

The entire investment sum of \$270,000 must be deposited into the Developer's Escrow Account as per new rules.

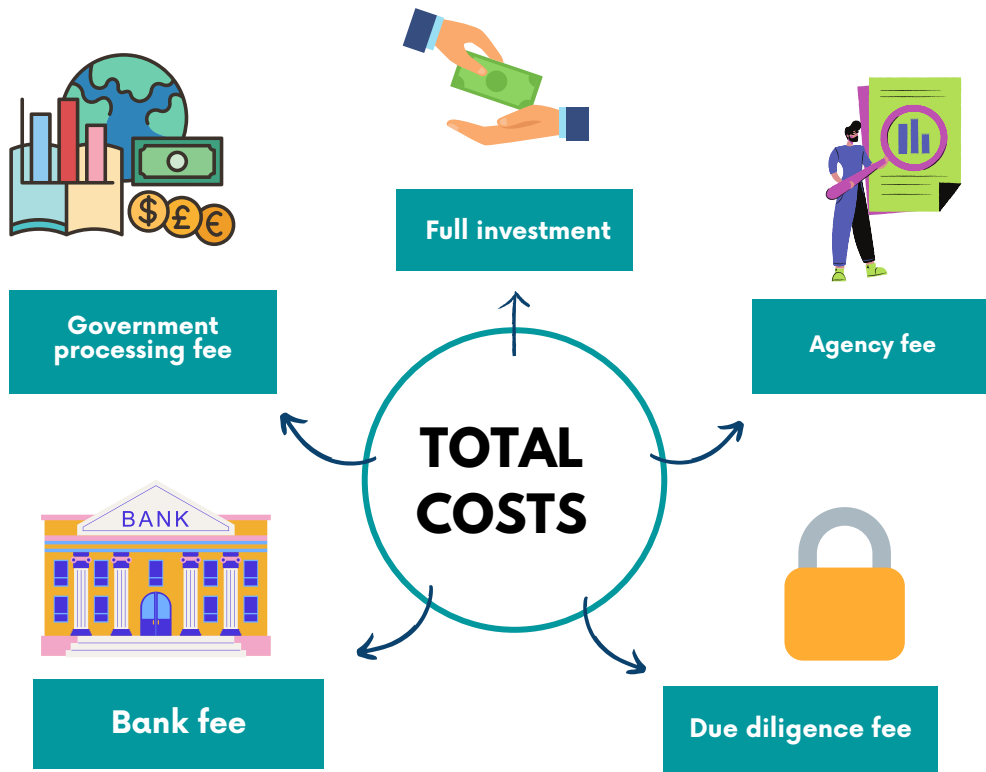

Legal Background

Grenada's Citizenship by Investment Programme allows individuals and their families to obtain citizenship or permanent residence. Applicants must apply through licensed agents, and may not make submissions to the Government on their own behalf.

The Citizenship by Investment Programme came into being in August 2013, when the Grenadian Parliament passed Act No. 15 of 2013, otherwise referred to as the 'Grenada Citizenship by Investment Act, 2013.' The stated objective of the Act is to "enable persons to acquire permanent residence and citizenship of Grenada by registration following investment in Grenada.

The Grenada Citizenship by Investment Committee (CBIC) is the Government body responsible for overseeing the processing of applications for citizenship by investment or by permanent residence. The CBIC assesses each application in accordance with the Grenada Citizenship by Investment Act, 2013. It then makes recommendations to the Minister, who has the final say on whether to approve, deny, or delay the granting of Grenadian citizenship.

Applications for Citizenship by Investment will be approved within 60 business days of submission (subject to a satisfactory due diligence check and the funds being received). You may apply for a passport shortly after. Passports are issued within days of the request.

All Grenadian passports are valid for five years and are recognized over 144 countries and territories as of 2021

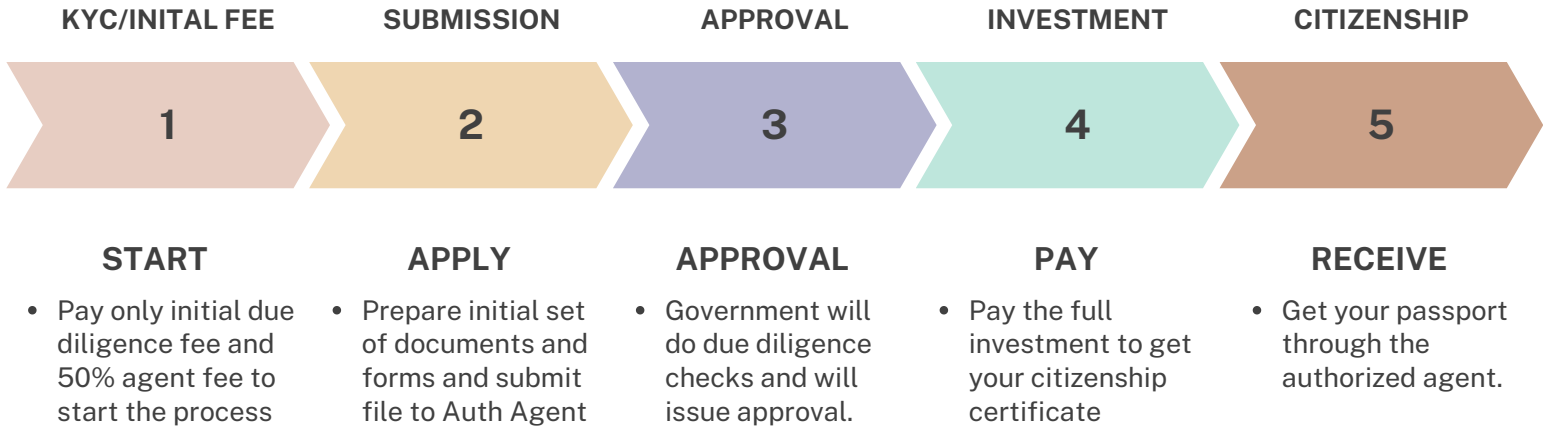

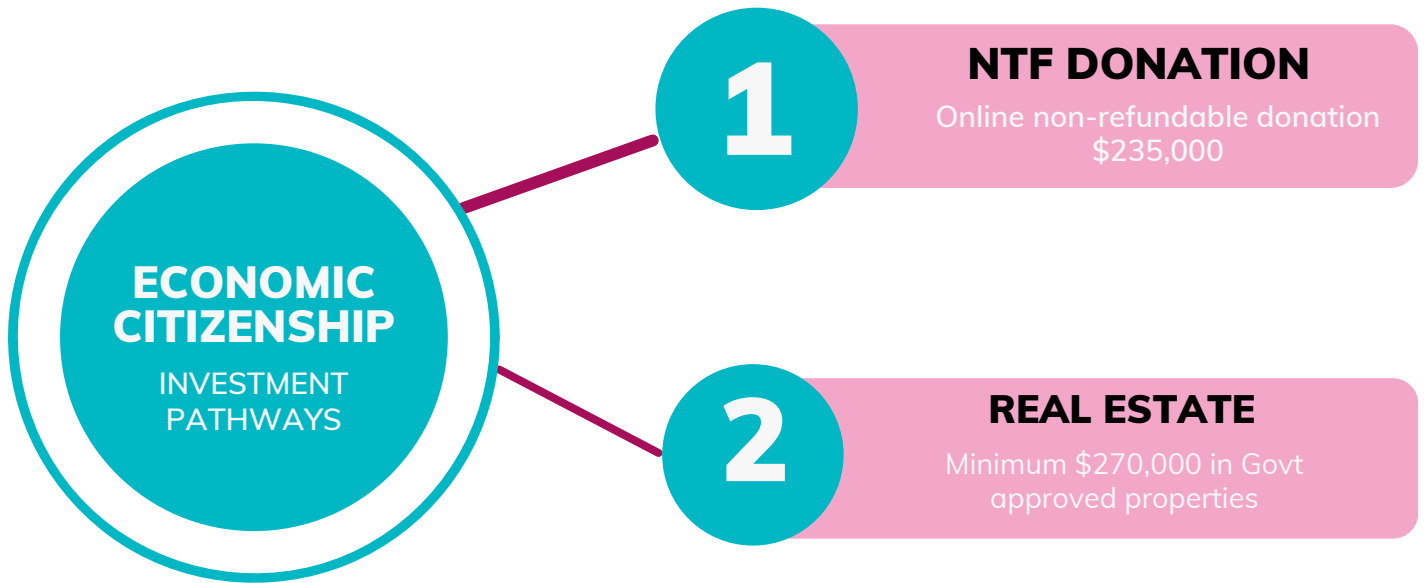

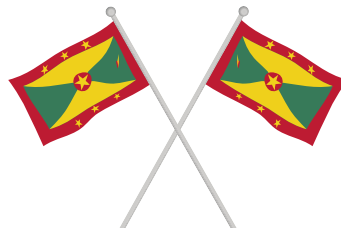

ELIGIBILITY



To apply to Grenada's CBI, applicants must be at least 18 years old and be capable of satisfying the financial responsibility of the application through legitimate and legal means. The following is also required:

- The applicant and his/her dependants must not have any communicable diseases.
- The applicant and his/her dependants must not be the subject of criminal investigations, or must not have been convicted for an offense in any country where the maximum penalty for the same, or a similar offence in Grenada, is more than six months.
- The applicant and his/her dependants must not have applied to another Caribbean CIP and received a denial.
- The applicant or his/her dependants must have received a subsequent visa approval from a country from which it received a visa denial in the past, if Grenada has visa-free privileges with that country.

DEPENDANTS

Grenada manages one of the most family friendly investment migration programmes in the world by allowing a multitude of family members to be included on one CIP application. These dependants are as follows:

- Spouse of the main applicant.
- Biological or adopted children of the main applicant or spouse under the age of 30
- Biological or adopted children of the main applicant or spouse of any age, who are physically, or mentally disabled.
- Parents or grandparents of the main applicant or spouse of any age.
- Biological or adopted siblings of the main applicant or spouse, who are 18 years or older, without child and unmarried (single).

New Born Babies

New born babies of the main applicant, born within 12 months of the grant of citizenship, are the only children that can be retroactively added to a citizenship application.

Administration Fee: \$100 | Application Fee: \$5,000

If the baby becomes the fifth person on the application, \$25,000 is also charged.

Required Documents

- Certified copy of ID Card
- Certified copy of passport
- Medical Certificate (HIV test) – Required for all applicants 12 years and over; Must be within 3 months.
- Original or Certified copy of Marriage Certificate (if applicable)
- Original or Certified copy of Birth Certificate (if applicable)
- Original Police Clearance Certificate – Required for main applicant, spouse and all dependants 17 y/o and above;
- Original Bank Reference Letter (Not older than 6 months)
- Marriage / Divorce certificates
- Six passport-size photos
- Statement of Source of Funds (main applicant only) – Investment portfolio, share certificate, bank statement, property sale records, inheritance, gifts etc.
- Photograph and Signature Certificate
- Affidavit of support for Dependents
- Investment Confirmation / Escrow agreement
- Proof of payment of non refundable processing and due diligence fees
- Official transcripts of written confirmation from a recognized education center (dependents over 18). Must be submitted for every country in which the applicant has lived for 1 year or more in the preceding 10-year period of the filing of the application. Validity must be less than 6 months old.



Due Diligence

The Grenada Citizenship Investment Unit performs several layers of background checks on applicants and their family members before being approved of citizenship and passports.

Authorized agents are required to perform KYC and initial due diligence checks on applicants as per government rules.

Applications may be refused for non-compliance such as fraud, concealment, previous visa denials, criminal background, money laundering and previous convictions.

All Candidates are required to seek CIU approval first before making the required investment (donation or real estate)

How to Start

1. Prepare initial documents: Police certificate, Birth Certificate, Passport ID copy and Medical certificate
2. Hire an Authorized marketing agent (we help you free of charge)
3. Pay Due diligence fee plus 50% of lawyer fee to submit file
4. Wait for CIP approval letter (2-3 months)
5. Pay your full investment to Government and remaining fee.
6. Collect your passport from consulate abroad

Any applicants who would present security or reputational concerns to the CBI programme and to the nation of Grenada, are turned away. Applicants who are already refused by other CBI programs automatically refused for Grenada.

NUTMEG

GRENADA

Grenada is the world's second largest producer of nutmeg. ... Inside the shell is a single glossy brown, oily seed — the nutmeg.

The use of nutmeg in traditional folk medicine is well documented. In India, Hindu physicians once used nutmeg to cure headaches, fever, bad breath, and intestinal disorders. In Arabian medical writings, nutmeg was touted as an aphrodisiac and a remedy for kidney and stomach ailments. Nutmeg oil, which is extracted from the fixed fat, is used in Grenada to relieve the pain associated with arthritis.

Commercially, nutmegs are utilised in the manufacture of perfumes, soaps and shampoos. A large portion of Grenada's nutmegs is used in the meat packing industry of Scandinavia to flavour various types of sausages. Nutmeg is also an ingredient in inhalants and liniments which are used to relieve congestion caused by influenza and colds. The use of nutmeg in traditional folk medicine is well documented.

MOLINERE

UNDERWATER SCULPTURE PARK



The sculptures that adorn the seabed of the Molinere Bay are among the outstanding landmarks of Grenada.

The sculptures are human figures and the fact that they are underwater creates an impressive atmosphere. In total there are more than sixty individual sculptures occupying an underwater area of over 800 square meters at a depth of up to 12 meters.

The Molinere Underwater Sculpture Park is a collection of ecological underwater contemporary art located in the Caribbean sea off the west coast of Grenada, West Indies and was created by British sculptor Jason deCaires Taylor.



In May 2006 the world's first underwater sculpture park was open for public viewing. The sculpture park is accessible via boat from the main port of St Georges (2 miles/3 km North of the capital) or Grand Anse Bay on the West coastline.

Vicissitudes depicts a circle of figures, all linked through holding hands. The sculpture proposes growth, chance, and natural transformation. It shows how time and environment impact on and shape the physical body. Children by nature are adaptive to their surroundings. Their use within the work highlights the importance of creating a sustainable and well-managed environment, a space for future generations.

The unique and one-of-a-kind underwater sculpture park in the Molinere Bay is the only park in the world with a collection of underwater modern art, located in the Caribbean Sea off the west coast of Grenada.

There are collection of over 65 sculptures is home to a number of species, which has been recently included in the World List of Tangible Tourist Attractions..



THE GRAND ANSEE BEACH

What is E-2 Investor Visa?

Learn the benefits of E-2 visas when compared to Eb-5 Green card

What is E-2 visa?

E-2 visa is a non-immigrant investment visa issued by United States. In recent years, E-2 visas became more popular than EB-5, because this visa is cheaper, faster and only low investment required (\$100,000 minimum but at least \$200,000 recommended). You must also create 5 jobs without which it is impossible to create jobs.

What are E-2 visa benefits from EB-5?

As of 2020, EB-5 requires \$900,000 investment and creation of 10 jobs. Many consider EB5 way too expensive and significant waiting times (years). There is a huge difference between these two programs.

How to use Citizenship by investment to get E-2 visa?

If you come from any of these non-E2 countries above the only way you will be eligible for E-2 visa is to use Citizenship by investment programs. Once you become a CBI citizen, you can file for E-2 visa at any US consulate, where you are resident or citizen of. E-2 visas are issued for maximum of 2 years with extensions.

Which is the cheapest CBI + E2 visa route?

Of all these Grenada is the cheapest route. You are looking at total costs about \$275,000 for Grenada passport (\$175K) and E-2 visa investment (\$100K). There are also US attorney costs.



A Little Secret with US E-2 Visa

First you should know the E-2 visa is a cheapest alternative to EB-5 immigrant investor program. It is the cheapest and fastest non-immigrant US visa. New changes in 2023 US immigration rules require CBI citizens spend **at least 3 years residence** in Grenada to become eligible.

Who would want to spend close to \$1 million for EB5 and the wait years and years for Green card? In Europe you only have to wait for few months. The United Kingdom if you invest €2m approves it just 1 or two weeks, fastest golden visa in world.

E-2 VISA MAKES IT CHEAPER WITH GRENADA

Instead you invest \$100,000 and create 5 jobs in the US you get E2 Visa in 3 weeks for 2 years.

Remember E2 is a non immigrant visa this is great if you don't want to live in US but visit anytime during Visa period

If you are from India, China, Nigeria, South Africa Russia ,Iraq, Lebanon etc. you cannot apply directly to E-2 visa. This is because there is no E-2 treaty signed between US and these countries.

This is where Citizenship by investment kicks in. You become a citizen of Grenada and apply for E2 non immigrant visa at any US consulate nearby where you live. You dont need to visit Grenada to apply for E-2 visa.

Grenada Passport + E2 visa route will cost you less than \$300,000 far far cheaper than EB5. Think about it

Be Careful if you step foot in US soil you could be liable to worldwide taxation. Plan your taxes before you immigrate to US.

Non E-2 Treaty Countries

We have compiled full list of countries that have no E-2 treaty agreement with United States. As a result nationals of these countries cannot apply for E-2 non-immigrant visas to enter United States. These country nationals can make use of Grenada citizenship to apply for E-2 investor visa to enter United States.

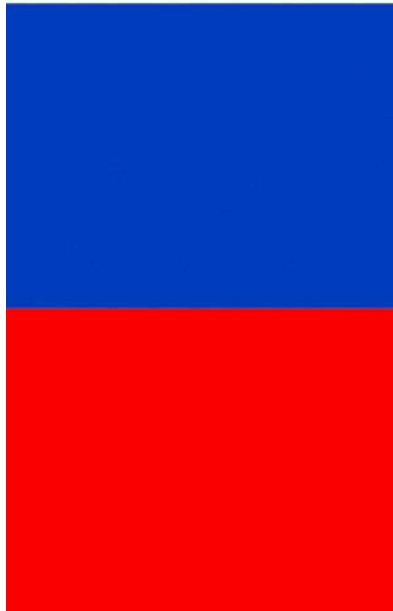

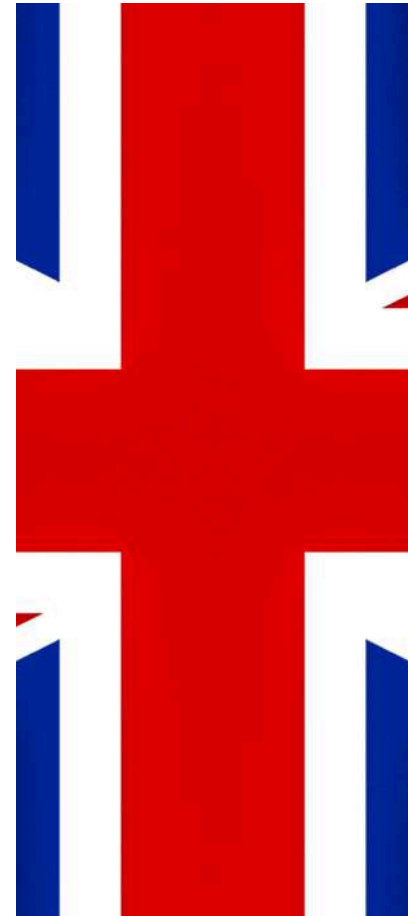

Grenada has a distinction of only few countries in the world whose citizens may travel without a visa to China, Russia, Schengen Area and the United Kingdom.

Free movement

Grenadian citizens can live and work in Antigua and Barbuda, Dominica, Saint Lucia, Saint Kitts and Nevis and Saint Vincent and the Grenadines as a result of right of freedom of movement granted in Article 12 of the Protocol of the Eastern Caribbean Economic Union of the Revised Treaty of Basseterre.

List of Visa Exemption Agreements

- Schengen Area – Mutual visa waiver agreement with Schengen Area countries on 28 May 2015
- China – Visa exemption treaty in force from Jun 10, 2015
- Russia – Mutual visa waiver with Russia signed on December 24, 2017
- Uzbekistan – Mutual visa waiver with Uzbekistan signed on October 15, 2019
- Moldova – Moldova Law signed on November 11, 2013,
- Ukraine – Exemption of visa with Ukraine signed on July 16, 2020



Q&A

What are the additional costs involved with the application?

A typical application comprises the following fee structure:

- Professional fees inclusive of marketing and local agent fees
- Deposit (if the applicant selects the real estate option)
- Investment (NTF or real estate)
- Application fee (\$1,500 per person)
- Processing fee (\$1,500 per person, who is 18 years or older and \$500 for persons younger than 18)
- Due diligence fee (\$5,000 per person, 17 years or older)
- Government fee (is payable only on real estate investments and is \$50,000 for up to a family of four and \$25,000 per each additional dependent)
- Oath of Allegiance fee (\$20)
- Passport fee (\$250 each)
- Bank charges.

What relatives can be included as dependants on family applications?

Grenada's Citizenship by Investment Programme allows an applicant to include his/her spouse; biological or adopted children under age 30; parents/grandparents of any age; and biological or adopted sibling(s), who are 18 years or older, childless, and single – of both the applicant and the spouse – all on one application.

Does Grenada accept polygamous marriage to include all of his wives on his application?

Grenada does not recognise polygamous marriages, and as such, applicants with multiple wives must select one wife to include as the spouse on the application.

What is the age requirement for children to be included on a citizenship application?

Children on family applications must be less than 30 years old, unless they are physically or mentally challenged, living with and fully supported by the main applicant, or his or her spouse.

Will a child, who is nearing his/her thirtieth birthday or who will turn thirty during the processing of the citizenship application qualify for inclusion on his/her parent's application?

As long as a child is 29 at the time the citizenship application is submitted to the CBIU, he/she will still be processed for citizenship. Can a married child of an applicant, who meets the age requirement, qualify as a dependant on the applicant's citizenship application? A married child cannot be included on his/her parent's citizenship application.

Can children of the applicant, who have children of their own, qualify as dependants on the applicant's citizenship application?

Children included on their parent's citizenship applications, must be single/unmarried, without children, and below the age of 30.

What is the age requirement for parents/grandparents to be included on family applications?

In Grenada parents/grandparents of any age can be included on family applications.

Can the parents/grandparents of the main applicant's spouse be included in the application?

Yes. The parents/grandparents of the main applicant's spouse can be included in the application.

Q&A

Must children be enrolled in school to qualify as dependants on a citizenship application?

Children are no longer required to be enrolled in school to qualify for inclusion on a parent's citizenship application.

Can an employed child be considered a dependant on an application?

Children, who are gainfully employed, cannot be included as dependants on their parent's citizenship application. Exceptions are made for children, whose jobs still require a level of dependency on their parents.

Can children from multiple marriages be included by the main applicant on his/her application?

Yes. Children of the main applicant and his/her spouse, who come from previous relationships or marriages can be included on family applications. However, whenever a child from a previous marriage is under age 18, an affidavit of consent from the ex-spouse, as well as a notarised copy of a photo ID from the ex-spouse is required for the child to be processed for citizenship.

Does a parent with full custody of his/her child require approval from the ex-spouse to apply for Grenadian citizenship for the child?

A parent, who has full custody of his/her child does not need to obtain an affidavit of consent from his/her ex-spouse.

What criteria must a sibling meet to qualify as a dependant on a citizenship application?

Siblings may be included on citizenship applications if they are 18 years or older, single, and without children.

Do siblings of the main applicant's spouse qualify for inclusion on the citizenship application?

Siblings of the main applicant's spouse, who are 18 years or older, single, and without children can also be included on the citizenship application.

Are adopted siblings eligible for inclusion on citizenship applications?

Adopted siblings of both the main applicant and his/her spouse who are 18 years or older, single, and without children can be included on the citizenship application.

What are the CIP processing times?

Your application for Citizenship by Investment will be approved within 60 business days of submission (subject to a satisfactory due diligence check and the funds being received). You may apply for a passport shortly after. Passports are issued within days of the request.

What forms/documents are required from dependants on citizenship applications?

- Form 1, 2, 3, & 4
- HIV test (12 years or older)
- Certified colour copies of current and expired passports
- Certified colour copy of national Photo ID
- Certified copy of birth certificate
- Letter of authorisation for those 17 years or older
- Police certificate(s)
- Ten passport sized photos (two notarised)
- Certified copy of marriage/divorce certificate (if applicable)
- Certified copy of military record(s) (if applicable)

What if applicants name changed other than marriage?

If a client's name has been changed through any other means than marriage, proof of the name change, such as a deed poll, a Chinese Household Register, or adoption papers, must be submitted with the application.

What if i cannot obtain a birth certificate?

Applicant is unable to obtain a birth certificate
If an applicant comes from a country where a birth certificate was not provided or is finding difficulty in obtaining a birth certificate from the relevant authority, a Household Register, Civil Status Certificate, or relevant document, can be provided along with an affidavit explaining the situation.

Do i need to visit Grenada?

No, you do not need to visit Grenada before, during, or after the application process.

How do i renew the expired passport?

Grenadian passports can be renewed in the Grenadian Consulate in London, or directly through the Grenadian Passport and Immigration Office.

Must i renounce previous citizenship?

Grenada allows dual citizenship, and you thus do not need to renounce any other citizenship or passport.

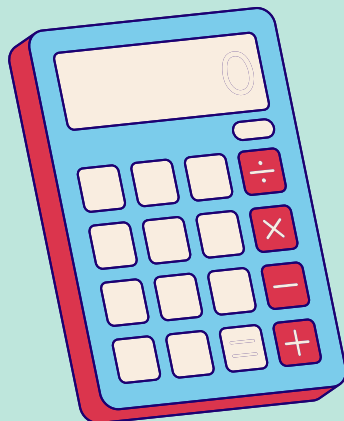
