**Citizenship (Capital Investment Immigration Plan) Regulation
(Amendment)
Order No.95 of 2025**

In exercise of the powers conferred on me by subsection 13C(1) of the Citizenship Act [CAP 112], I, the Honourable JOTHAM NAPAT, Prime Minister, make the following Order.

1 Amendments

The Citizenship (Capital Investment Immigration Plan) Regulation Order No. 8 of 2023 is amended as set out in the Schedule.

2 Commencement

This Order commences on the day on which it is made.

AMENDMENTS OF THE CITIZENSHIP (CAPITAL INVESTMENT IMMIGRATION PLAN) REGULATION

1 Subclauses 3(2)

Delete "The", substitute "Subject to subclauses (3) and (4), the"

2 Subclause 3(3)

Delete "an", insert "a detailed"

3 Subclause 5(1)

Delete "USD115,000 or AUD179,000 or VT13,900,000", substitute "USD160,000 or AUD248,000"

4 Subclause 5(2)

Delete "or VT7,800,000"

5 Subclause 5(2A)

Delete "USD55,000 or AUD85,000 or VT6,100,000", substitute "USD50,000 or AUD77,000"

6 Subclause (2AB)

Repeal the subclause, substitute

"(2AB) The designated agent must use USD50,000 or AUD77,000 for the purpose of investing in its sector for investment and must not use the amount for any other purpose.

(2AC) The designated agent must, after 5 years of investing in its sector of investment, pay a revenue raised from the investments to the designated Government account.

(2AD) The revenue to be paid under subclause (2AC) is to be determined by the Commission."

Delete "request", substitute "appoint"
